The Hartington City Council met for a public hearing and their regular meeting on February 24, 2020 at the city hall beginning at 7:00 P.M. Notice of time and place of the hearing and meeting was given in the advance notice by publishing and posting. Notice of time and place of the meeting was communicated in the advance notice to the mayor and council.

Present were Mayor Becker; Councilmen Sudbeck, Christensen, and Bartling; City Clerk – Treasurer Schaecher, Deputy Clerk Becker, and Legal Advisor Pier. Councilman Peitz was absent.

Mayor Becker opened the public hearing for the Final Plat of Carol Peterson's Addition at 7:00 P.M. Clerk Schaecher explained that the Planning and Zoning Commission met on January 29, 2020 and approved the plat. There were no public comments and no comments from the Council, so Mayor Becker closed the hearing at 7:02 P.M.

Mayor Becker called the regular meeting to order at 7:02 P.M., followed by all present reciting the Pledge of Allegiance. He announced that the open meeting law poster was on the back wall of the council room and reminded all present to silence their cell phones.

A motion to approve the minutes of the February 10, 2020 meeting was made by Christensen and seconded by Sudbeck. A roll call vote was taken. Bartling – yes, Christensen – yes, and Sudbeck – yes. Motion carried.

The January 2020 Cedar County Sheriff's report was distributed by Deputy Vacha. There were 435 ¼ hours patrolled. School traffic was 6 ¼ hours. Calls of service were 3 EMS assists, 2 welfare checks, 2 accidents, 1 EPC, 1 disturbance, and 1 search warrant. Traffic stops were 3 verbal warnings, 0 written warnings, and 2 citations. There was 1 arrest.

A building permit for Dan Kollars – Garden Shed was presented and reviewed. Councilman Bartling made a motion to approve the permit and this was seconded by Sudbeck. A roll call vote was taken. Bartling – yes, Christensen – yes, and Sudbeck – yes. Motion carried.

Clerk Schaecher reported to the Council that Wendy Wortmann and Nancee Sudbeck are interested in being on the Park Board. Councilman Bartling made a motion to approve the members and this was seconded by Christensen. A roll call vote was taken. Bartling – yes, Christensen – yes, and Sudbeck – yes. Motion carried.

Mayor Becker discussed the Cash Rent Farm Lease Agreement in which the City has with Darin Pick. There are no changes from last year's lease. A motion to approve the Cash Rent Farm Lease was made by Councilman Christensen and seconded by Councilman Bartling. A roll call vote was taken. Bartling – yes, Christensen – yes, and Sudbeck – yes. Motion carried.

Resolution 20200224 – Approving the Final Plat of Carol Peterson's Addition was introduced by Councilman Sudbeck. A motion to adopt the resolution was made by Bartling and seconded by Christensen. A roll call vote was taken. Bartling – yes, Christensen –yes, and Sudbeck – yes. Motion carried.

The LB840 loan No. 2020211 was introduced by Clerk Schaecher, stating the Revolving Loan Fund Committee recommends a \$50,000 loan be approved for Creamer Auction Company/Ryan Creamer for 15 years at 0% interest for building acquisition and renovations. The loan will be secured by a second lien on the real property. A recommendation is for the first payment to be due by ACH payments each month, starting July 01, 2020. A motion to approve the loan was made by Christensen and seconded by Bartling. A roll call vote was taken. Bartling - yes, Christensen – yes, and Sudbeck - yes. Motion carried.

Councilman Sudbeck presented bids for the replacement of 2 hanging heaters in the auditorium. Sudbeck recommended the Council accept the bid of Koch-Tramp Plumbing & Heating for the amount of \$7,269.00. The work will take place in June and the ceiling work that was on this year's budget will be pushed into the next budget. A motion to approve the bid for Koch-Tramp plumbing & Heating was made by Christensen and seconded by Bartling. A roll call vote was taken. Bartling – yes, Christensen – yes, and Sudbeck – yes. Motion carried.

Kerry Dendinger and Jeff Jones approached the Council with an indoor/outdoor shooting range proposal. The plan is to start with an outdoor range and eventually add an indoor range. Jeff Jones stated President Trump had signed a bill in 2019 this has given Game and Parks more ability to give grants. Jeff has received a grant for a \$9,000 trap from the National Rifle Association and has looked into the fairgrounds as a shooting spot, but it needs a 300-yard fall safety zone. Jeff stated the land by the recycling center would be optimal, as the old gravel pit area could be used, and wondered if the City

would be interested in allowing a range to be built on City grounds. Kerry asked if the entrance to the range could be shared with the recycling center and Mayor Becker stated that would not be an option, as that needs to stay secure. Mayor Becker asked for a drawn-out site plan so the Council could get more of a feel as to what their plans are going to be. Mayor Becker also asked if there was a specific time frame for their project. Jones stated with the NRA grant, placement needs to be established by November 01, 2020. Mayor Becker stated Darin Pick will have to be given notice, as he rents the land from the City in that area. Kerry asked if there could be a certain contact person from the council with whom they work with and Councilman Bartling stated he would act as liaison. Kerry voiced hopes to be open by Spring of 2021.

ACE has returned \$23,617.00 back to Hartington since 1998.
