The Hartington City Council met on November 08, 2021 at the city hall for their regular meeting beginning at 7:00 P.M. Notice of time and place of the meeting was given in the advance notice by posting. Notice of time and place of the meeting was communicated in the advance notice to the mayor and council.

Present were Mayor Becker; Councilmen Sudbeck, Peitz, and Bartling; City Clerk – Treasurer Schaecher; and Deputy Clerk Carlson. Councilman Christensen and Legal Advisor Pier were absent.

Mayor Becker called the meeting to order at 7:01 P.M., followed by all present reciting the Pledge of Allegiance. He announced that the open meeting law poster was on the back wall of the council room and reminded all present to silence their cell phones.

A motion to approve the minutes of the October 25, 2021 meeting, the November 01, 2021 Special Meeting, and October 2021 Treasurer's Report was made by Bartling and seconded by Sudbeck. A roll call vote was taken. Bartling – yes, Peitz – yes, and Sudbeck – yes. Motion carried.

The October 2021 Cedar County Sheriff's report was distributed by Deputy Greiner. There were 421 ½ hours patrolled. School traffic was 3 ¾ hours.
