



HARTINGTON SOCCER 2024

The Hartington Soccer League will run from August 26th to October 5th. Children who are 5 and older on or before September 1, 2024 through 4th grade are eligible to sign up for the soccer league. There are 3 divisions: 5 years old/Kindergarten, 1st/2nd grades and 3rd/4th grades. These are subject to change depending on the number of participants. Practice will be held for 45 minutes once a week on either a Tuesday or Thursday beginning on August 27th with games being played on **Saturday** afternoons beginning on September 7th.

There is a **\$20.00 fee** per child.

PLEASE SEND THIS FORM AND A \$20.00 REGISTRATION FEE TO SCHOOL OR THE HARTINGTON CITY OFFICE BY FRIDAY, AUGUST 16TH.

Checks need to be made payable to Hartington Soccer. A late fee of \$25.00 per child is required if payment is received after the date of August 16TH.

Your child will be given a shirt to be used for games and must be returned back to the coach on the last game.

All players will need to bring shin guards to every practice and game.

Teams, practice times and games schedules will be sent home from school with all players at the end of the week of August 26th.
