The owner of the Skylon Ballroom and The City of Hartington have come up with a plan to save the Skylon Ballroom and make sure that Hartington has a community event center as well. The city's plans for a private-public partnership of the Skylon so it can be better used as a community event center. The owner of Skylon Ballroom has agreed to move and update the facility at his own expense. Thank you to the generosity of a few people for the possibility of preserving a new and improved Skylon event center in a new location. The city will then purchase the Skylon over a seven-year period. The new community event center could be opened by late fall or early winter of 2025.

The City of Hartington council members are anticipating another Town Hall meeting sometime in September to further explain the project more to local residents.

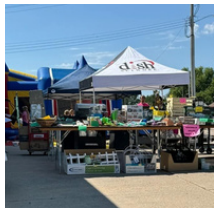

ORDINANCE No. 905, updating sections 7-201 through 7-207. Public Nuisances including dead trees, tires, and abandoned vehicles.

It shall be the duty of every owner of real estate in the City to keep that real estate free of public nuisances. The city superintendent shall document the nuisance by photographing, then the City shall give notice to abate the nuisance to each owner, by personal service or certified mail. Such notice shall contain a copy of the photograph of the nuisance, a copy of this ordinance, instructions on abatement of the nuisance, time in which such abatement shall take place, and possible penalties for failure to abate. However, if notice cannot be given via personal service or certified mail with reasonable diligence, the City shall give notice to abate and remove such nuisance to each owner by leaving and posting the notice on the premises or by publication for one (1) week in some newspaper printed in Cedar County, Nebraska.

Within five (5) business days after receipt of such notice the owner of such nuisance, may request a hearing with the City to appeal the order to abate or remove the nuisance by filing a written appeal with the office of the City Clerk. The Mayor shall render a decision on the appeal within five (5) business days after the conclusion of the hearing. If no appeal is taken within ten (10) days of the Mayor's decision, the owner shall promptly comply with the notice to abate. If within ten (10) day the owner fails to comply with the order to abate and remove the nuisance, charges to be filed against the owner of the premises for maintenance of a nuisance. 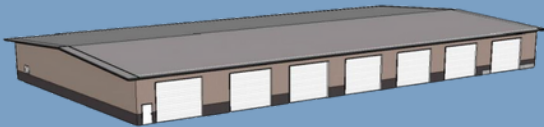

It is unlawful for any person under the age of nineteen (19) years to loiter, wander, stroll, or play in or upon the public streets, sidewalks, highways, roads, alleys, parks, public places and public buildings, vacant lots or other unsupervised places, or to ride in or upon, drive, or otherwise operate any automobile, bicycle, or other vehicle upon the streets, alleys, or other public places of the City, between the hours of (12:00) Midnight and (5:00) A.M. except on Friday and Saturday, when the curfew hours is from (1:00) A.M. to (5:00) A.M.. Curfew hours are not applicable if such minor person is accompanied by an adult parent, guardian, or legal custodian. (Ordinance § 10-203)

City Shop Update



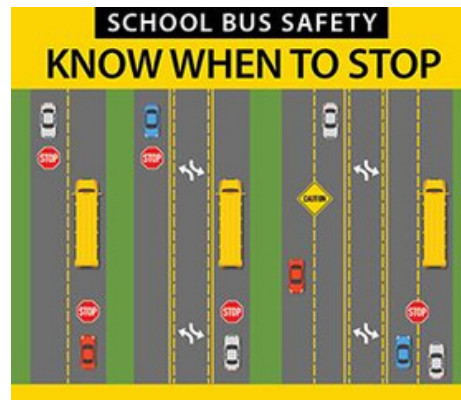
A motion was made on Monday August 12th to approve the bid portfolio for the City Shop to be released to the public.
