

ORDINANCE NO. 907

AN ORDINANCE OF THE CITY OF HARTINGTON, NEBRASKA, ADDING SECTIONS 6-501 THROUGH 6-506 TO CHAPTER SIX TO CREATE THE HARTINGTON HELPS PROGRAM AND REGULATIONS; REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES THAT CONFLICT HEREWITH; AND PROVIDING A TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HARTINGTON, NEBRASKA THAT SECTIONS 6-501 THROUGH 6-506 BE ADDED TO THE CITY OF HARTINGTON CODE OF ORDINANCES AS FOLLOWS:

§6-501 HARTINGTON HELPS CREATION

There is hereby established a billing contribution program for the purpose of facilitating contributions by City of Hartington public works customers to fund community projects to be known as "Hartington Helps." The Hartington Helps program shall be a contribution program where City of Hartington public works customers can opt in to have their bills rounded up to the nearest dollar to contribute to the Hartington Helps program. Customers shall be permitted to opt in or opt back out at any time.

§6-502 HARTINGTON HELPS COMMITTEE CREATION

There is hereby established a Hartington Helps Committee. The Hartington Helps Committee shall review applications submitted for funding from Hartington Helps and shall approve or deny each application. The Committee shall approve all expenditures of Hartington Helps funds.

§6-503 HARTINGTON HELPS COMMITTEE COMPOSITION AND MEMBERSHIP

The Hartington helps Committee will be comprised of three (3) members. The membership of the Committee shall consist of the City Clerk, the Mayor and one City Council Member.

§6-504 HARTINGTON HELPS COMMITTEE APPOINTMENT

The Hartington Helps Committee shall be appointed by the mayor with the approval of the city council. Members of the Hartington Helps Committee will serve at the will of the mayor.

§6-505 HARTINGTON HELPS COMMITTEE OFFICERS AND QUORUM

The Hartington Helps Committee shall select a chairperson from its members and may create and fill such other offices as the advisory board determines necessary. A total of two (2) members of the Hartington Helps Committee shall constitute a quorum for the transaction of business.

§6-506 HARTINGTON HELPS ADVISORY BOARD MEETINGS

The Hartington Helps Committee shall meet at least quarterly to review applications submitted for funding from Hartington Helps.

This Ordinance shall take effect upon its passage and approval and publication as required by law.
