The Hartington City Council met for their regular meeting on March 24th, 2025 at City Hall beginning at 5:00 P.M. Notice of time and place of the meeting was given in advance notice by posting. Notice of time and place of the meeting was communicated in the advanced notice to the Mayor and Council.

Present were Mayor Becker; Councilman Christensen, Kathol, and Sudbeck; City Clerk-Treasurer Benscoter, Deputy Clerk Schulte, and Legal Counsel Nikki Brandt. Councilman Bartling was absent.

Mayor Becker called the meeting to order at 5:02 P.M., followed by all present reciting the Pledge of Allegiance.

A motion to approve the minutes from the February 24th, 2025 meeting and the February 2025 Treasurer's report was made by Councilman Christensen and seconded by Councilman Kathol. A roll call vote was taken. Christensen – yes, Kathol – yes, Sudbeck - yes. Motion carried.

Brittney Koenig with NPPD met with Council for the NPPD annual Retail Update. She stated the current lease agreement with NPPD and the City is 12% and in 2024, NPPD collected and remitted \$269,003.74 in lease payments and \$24,591.63 in city sales tax in Hartington. NPPD is deploying and utilizing technology to create efficiency through LED lighting, advanced metering and data analytics. In 2024, \$9,589.80 in incentives were received by customers in Hartington. She stated NPPD follows the 3 R's of Rate Stability, Reliability, and Relationships; serves 93,000 customers in 84 counties in Nebraska. They have a mobile app to better serve their customer's needs. The average kilowatt cost per hour for homeowners in the State of Nebraska is \$0.1124 and NPPD is below that average at \$0.1098 per kilowatt hour. For 2014-2024, NPPD did not raise their rates, but due to increasing input costs they did increase rates by 2% for 2025 which would be an increase of \$3.25 per month for an average residential retail customer who uses 1,000 kWh of electricity a month.

Building Inspector, LeRoy Hansen, introduced the sign permit for The Residency. They have a new sign out front of the building located at 403 S Robinson Ave. A motion to approve the sign permit for The Residency was made by Councilman Christensen and seconded by Councilman Sudbeck. A roll call vote was taken. Christensen – yes, Kathol – yes, Sudbeck - yes. Motion carried.

Building Inspector, LeRoy Hansen introduced the building permits for Matt and Kathie Dresden for new home construction and David Newsam for new shop. A motion to approve the building permits for Matt and Kathie Dresden and David Newsam was made by Councilman Christensen and seconded by Councilman Sudbeck. A roll call vote was taken. Christensen – yes, Kathol – yes, Sudbeck - yes. Motion carried.

The February 2025 Cedar County Sheriff's Report was reviewed. There were 401 hours patrolled. School traffic was 2½ hours. Calls of service were 1 EMS Assist, 2 Welfare Checks, 1 Disturbance, 1 Recover Stolen Vehicle, 3 Traffic Controls, 1 Accident. Traffic stops were 0 Verbal Warning, 0 Written Warning, and 0 Citations. 3 Arrests was made.
